Construction Law 101 is a training series built to give newer construction lawyers the foundation they actually need in practice. The program delivers fifteen one-hour sessions—each focused on a core building block of construction law, from project anatomy and delivery models to design contracts, scheduling, changes, claims, insurance, liens, dispute resolution, bankruptcy, damages, and working with experts.
